I have two projects I would like to implement with the approval and assistance of the Metropolis Council. First, I hope to implement a program for reaching out to Greek Orthodox Christians who were married in the Church, or grew up in the Church, but have fallen away. This effort--the Domestic Orthodox Missionary Effort ("DOME")--will be challenging because the "Distantly Connected" are among the hardest to reach, but if they are welcomed back with love and compassion, my hope is that they will once again become active members of our communities.
